PLEASE READ THE FOLLOWING INFORMATION CAREFULLY

- ❖ Information on this Application must be completed by the applicant for each alarm site.
- ❖ A permit must be obtained prior to the activation of an alarm system.
- ❖ It is the responsibility of the applicant to keep all information listed on the Alarm Permit Application current.
- ❖ The cost of the Permit is \$15.00, payable to the City of Bowling Green.
- ❖ Renewals of Permits for Businesses are \$15.00. Renewals of Permits for Residences are at no cost.
- ❖ The Permit is valid for one (1) year from issue/renewal date.
- ❖ The Permit is not transferable to a new owner or occupant of the Permit site.
- ❖ The Permit is not transferable to a different location by the Permit holder.
- ❖ The Permit holder shall conspicuously post the Alarm Permit sticker at the front entrance of the Permit site such that it is reasonably visible from the front of the site.
- ❖ The Permit site will be allowed three (3) false Police alarms and three (3) false Fire alarms during a 12 month period as described above without fines imposed. Each additional false alarm shall be fined as follows: \$25.00 for the fourth, \$50.00 for the fifth, \$75.00 for the sixth and \$100.00 for each additional false alarm.
